

WOODSTONE OF LOUDOUN HOA 2022 POOL RULES AND REGULATIONS

The following rules and regulations are for the benefit and protection of all members and their guests. They have been established by the Board of Directors to ensure the safe and sanitary operation of the facilities and to provide enjoyable recreation for the mutual pleasure of all the members and their guests. Infractions by an individual member or guest may result in temporary suspension of pool privileges. These rules are in compliance with the Swimming Pool Ordinances and Regulations of Loudoun County, Virginia.

Section 1 - Pool Management

- A. The Board of Directors has delegated authority to the pool management staff for the safety, daily maintenance and cleanliness in and around the pool area, supervising the operating staff, and proper enforcement of the Rules and Regulations established by the Board of Directors. This pool management staff will be in full charge of the pool facilities at all times.
- B. Each member of the pool management staff has responsibility for the enforcement of the rules and regulations. Parents are asked to remind their children to observe all rules and regulations and to obey the instruction of the manager and staff. Children and adults are expected to show the staff proper respect and cooperation at all times. The management staff shall take such action as deemed necessary for the safe and orderly operation of the facilities.
- C. As agents for the Board of Directors, the pool management staff has authority to temporarily suspend pool privileges for breaking rules or for any other reason which, in their judgment, constitutes a hazard, a nuisance to others, or interferes with the management of the pool area. Pool management shall record such suspensions and report them to the Board of Directors. Any member receiving three (3) suspensions will surrender their pool privileges for the remainder of the season. The Board of Directors reserves the right to suspend pool privileges for more serious offenses, including, but not limited to, trespassing, fighting, vandalism, etc.

Section 2 - Pool Admission Requirements

- A. Use of the pool area and pool is by permission only. The lifeguard must be on duty and the pool officially opened before any user is allowed into the pool area or into the pool.
- B. All persons using the pool area or pool do so at their own risk and sole responsibility.
- C. All homeowners must register for pool admission via the registration form provided by the Association. In accordance with the HOA documents, admission to the facilities shall be given only to members in good standing with their HOA dues and no outstanding covenant violations.
- D. All persons over age 3 using the facilities are required to present their **valid** photo ID card issued by the Association. The ID cards will be left at the front desk and picked up when exiting.
- E. Children under age 12 must be accompanied and supervised by an authorized pool user over the age of 16 who must remain with and be responsible for the children at all times. Young teens should not supervise more than two children under 12. Pool management reserves the right to determine whether children under age 12 are receiving adequate supervision.
- F. Only genuine swimwear may be worn in the pool. Cut-offs, walking shorts, thongs-type swimwear, and apparel of the like are not permitted in the pool. No street footwear will be permitted on the concrete apron portion of the pool area. It is required that coverings be worn TO and FROM the pool area at all times.
- G. Except for wheelchairs or baby strollers, wheeled devices, e.g. bicycles, skate boards, tricycles, may not be used in the pool area. Wheelchairs and baby strollers must be kept ten feet from the edge of the pool.

Section 3 - Pool Operation

- A. The pool may be closed at any time due to equipment breakdown, operational difficulties, or inclement weather. The decision is at the sole discretion of pool management.
- B. No breach of the peace, e.g., loud CD players, radios or tape players, abusive or profane language, will be permitted.
- C. All beverages or food brought into the pool area must be in paper or plastic containers and be consumed in the grass portion of the pool complex. All trash must be disposed of in a trash can.
- E. Lifeguards may administer a swimming test to any pool user to determine the level of self-sufficiency of that pool user in the pool.
- F. All bathers must shower before entering the pool. Bathhouses, showers, and sanitary facilities are provided.
- G. Infants and children wearing diapers, or who are not toilet trained, must wear swimmers with tight-fitting rubber pants in the pool.
- H. Admission to the pool area shall be refused to all persons having infectious disease, sore or inflamed eyes, colds, nasal or ear discharges, or any communicable disease of any kind. Persons with excessive sunburn, open sores, or bandages of any kind will not be permitted access to the pool area.
- I. Running, pushing, wrestling, ball playing, or causing undue disturbance in or about the pool area will not be permitted. Spouting of water and similar unhygienic acts will not be permitted in the pool.
- J. No life preservers, inner tubes, water wings, or play equipment may be used in the pool. The lifeguards will decide on individual requests for other play equipment, as they deem safe and according to the number of people in the pool. This will be an absolute lifeguard decision as they are ultimately responsible for everyone's safety. (This does not include instructional devices used in conjunction with training under the direction of qualified pool attendants).
- K. All swimmers shall exit the pool immediately when the guard leaves his/her station or upon the lifeguard's request.
- L. ABSOLUTELY NO alcoholic beverages or other intoxicants may be brought into the pool area.
- M. Smoking is NOT permitted in the pool area.
- N. No pets are allowed in the pool area.
- O. Management will not be responsible for loss of or damage to any personal property of any kind.
